#### Project Need (include cost of No Action):

The water mains in 40% of Bayou La Batre's water system have been determined to be undersized and to lack adequate flow for fire protection. Water pressure is also a problem in some areas. 7200 linear feet of waterfront and several public schools within the area have low water pressure or low water capacity to ensure adequate fire protection due to undersized water mains. The City of Bayou La Batre proposes to replace 86,200 linear feet of 2-inch water lines with 6-inch or larger lines to improve water pressure and fire protection. Many residents will see a drop in home insurance rates due to better fire protection near their homes. This increased capacity will also allow the City to be ready for any growth to residential, commercial and recreational developments. If this project is not performed ("no action"), many residents, schools and businesses will continue to have low water pressure and inadequate fire protection.

#### Project Purpose:

The purpose of the project is to replace undersized water mains with larger ones, to provide adequate water pressure and fire protection for many areas within Bayou La Batre Utilities Board service area.

#### **Project Objectives:**

The objective is to replace 86,200 linear feet of undersized water mains with larger-sized mains.

This project meets the primary activity of "Infrastructure projects benefitting the economy or ecological resources, including port infrastructure" by benefitting the local economy in supporting adequate water pressure, including preventing the loss of homes by fire due to inadequate fire protection. This project also will provide better water capacity to additional residential, business or recreational developments that may occur in the area.

  documents related to the assistance; and will establish


