Project Need (include cost of No Action):

<u>Description</u>: The Alabama State Port Authority (ASPA) is proposing to convert a derelict former Bulk Handling Facility into a state-of-the-art Roll On-Roll Off (Ro-Ro)/Mobile Vehicle Processing Facility (the Facility) at the Port of Mobile, Alabama. The Facility will complement and support the emergence of automotive import and export supply chains through the Port of Mobile, AL.

The proposed Facility, which will be served by five Class 1 railroads and has nearby interstate highway access, will be used for the handling of Ro-Ro units, to include but not be limited to: automobiles, military vehicles, trucks, other rolling stock, and high/heavy cargos loaded on roll type trailers.

The development of the Facility will allow automobile and equipment manufacturers in Alabama and other neighboring states access to a more cost effective deep-water gateway for exporting American made products, as well as importing commodities and components that support those manufacturers. This will help the nation compete in the global economy, creating jobs and improving the regional and national economy.

The proposed Vehicle Processing/Ro-Ro Facility is being developed under an innovative Public-Private Partnership (P3) arrangement that been employed successfully by ASPA several times within the past 15 years. ASPA will still be the party responsible for overall design, environmental permitting, and construction. Once the terminal is built, the

Alabama State Port Authority will partner with a concessionaire that will operate the facility under a long-term lease. The concessionaire will be required to make a financial contribution towards the capital costs. The cost that the concessionaire will cover is \$10,430,940.

<u>Need:</u> Currently, the Port has the capability to dock Ro-Ro vessels at Pier E, but has no support facilities and limited open storage for the equipment. The new Facility will give the Port capacity for 139,000 Ro-Ro units and 180,000 at full build-out. These increased operational capabilities will allow the Port to boost their importing and exporting capabilities, support regional manufacturing, and break into the Ro-Ro freight movement market.

Project Purpose:

The purpose of this project is to allow automobile and equipment manufacturers in Alabama and other neighboring states access to a more cost effective deep-water gateway for exporting American made products, as well as importing commodities and components that support those manufacturers. This will help the nation compete in the global economy, creating jobs and improving the regional and national economy.

Project Objectives:

The objective of this project is to construct a state-of-the-art automobile Ro/Ro and processing facility.

How the project/program meets the identified primary activity designated in A1

The primary activity identified in A1 is "Infrastructure projects benefitting the economy or ecological resources, including port infrastructure" combined with a secondary activity of "Workforce development and job creation". This project has an economic benefit-cost ratio of 1.21 considering only economic benefits to the freight transportation system, without factoring in job creation. In addition to the transportation system economic benefits it will create more than 500 new direct, indirect and induced jobs.

We will have two (2) milestones. The first milestone will be **Pre-Construction activities**, which will include Field Investigations, Final Design, permitting and procurement of the construction contract. These activities will take approximately 11 months to complete. The second milestone will be the **Construction** of the facility, which will take approximately 15 months.

The total cost of the Alabama State Port Authority Automotive/ RO-RO Terminal is \$51,898,650. The project will be funded with TIGER Grant funds, ASPA funds, Private Concessionaire funds and RESTORE funds. The amount of RESTORE funding that we are requesting is \$28,767,710. The project will convert a derelict former Bulk Material Handling Facility into a state-of-the-art Ro-Ro Mobile Vehicle Processing Facility. Without grant support this project cannot proceed. The funds will be allocated to the following budget categories: Maintenance Department relocation expenses, architectural and engineering fees, project inspection fees, site work, demolition and removal, construction, miscellaneous and a 20% contingency rate. Contractors will be procured to perform all engineering and construction activities. Any contractors or subcontractors performing work on the project will be competitively procured and in compliance with all Federal regulations in 2 CFR Part 200, RESTORE Act Standard Terms and Conditions provided by the U.S. Department of Treasury and in accordance with Alabama State Port Authority policies and procedures and Alabama State Law. The Alabama State Port Authority does not plan to charge any indirect costs or general administrative costs including general accounting, personnel or general expenses associated with providing the services required to administer a Federal award. These costs will be funded with Alabama State Port Authority operating revenues.



Risks:
1. The challenges that may delay the Alabama State Port Authority / RO-RO Terminal include the timely negotiation and completion of the P3 procurement. A P3 Partnership is a cooperative agreement between a public sector entity and a private sector entity that outlines the provision of assets. It is possible that the concessionaire could view currency fluctuations as risky, making new and used automotive exports less competitive.
2. There may also be a challenge due to the concessionaire's perception of the reliability of rail service to the project site, and the desire to have one or more Class 1 providers to deliver imports and exports in a timely fashion.
3. While poor soils are often a challenge for marine projects, the lack of excavation and the previous heavy-use bulk facility indicate that this is a very low risk for the Project.
Mitigation Strategy:
1. This risk will be mitigated through contract negotiation with the Concessionaire. Such provisions are typical in global trade agreements.
2. This risk will be mitigated by the active engagement of ASPA in the rail negotiation and oversight process for the facility. This type of risk sharing is common among US seaports.
3. ASPA will mitigate this risk by ensuring that fill brought to the site to increase elevation will be properly inspected and compacted to meet ASPA and contractual standards.

stemming from the optimization of the auto import/export industry throughout Mobile's Least Cost Market Area (LCMA), resulting in reduced mileage and operating costs for truckers and railroads. On the truck side, this will also lead to reduced congestion on U.S. Highways and lower air emissions from trucks increasing the benefits associated with the economic competitiveness of the Project. The project will also create more than 500 new direct, indirect

- The purpose of the RESTORE Act is to provide funding for ecological and economic recovery efforts for damages incurred as a result of the Deepwater Horizon Oil Spill. Please discuss how the proposed project's implementation will prevent any adverse impacts elsewhere.

This project will support the continued growth of the Automobile Manufacturing industry in the State of Alabama. The facility will also diversify the mix of commodities transported through the Port of Mobile with a corresponding increase in the economic resiliency of the Alabama Gulf Coast. Increase economic resiliency will help the local economy withstand the impacts of both natural and man-made disasters such as the Deepwater Horizon.

- Does the proposed project expand or promote an existing industry or offer diversification? If so, please explain:

The new facility will allow the port to break into the Ro-Ro freight movement markets, which will make the port more diversified. It will also support the Automobile Manufacturing industry in the State of Alabama.

Currently, there are no regional automotive RO/RO logistics terminals serving Alabama and adjoining regional automotive manufacturing and assembly markets. The new facility will bring an existing industry to the region.

- Does the proposed project create short-term job opportunities? If so, how many? Please justify:

Yes, the total direct and indirect jobs for the construction period are estimated to be 528 while total direct, indirect and induced jobs for the same period are estimated to be 782.

- Does the proposed project create long-term job opportunities? If so, how many? Please justify:
- Yes, based on the Bureau of Economic Analysis' Regional Input-Output Modeling System (RIMS II), the total number of direct and indirect jobs created by the operation of the facility is estimated to be 170 jobs. Including induced jobs, the total number of jobs created by this facility would be approximately 532.
- Please discuss how the proposed project will be sustained post-implementation including any annual recurring costs

The Alabama State Port Authority plans to enter into a concessionaire partnership agreement with a private terminal operator to operate and maintain the facility. The concessionaire and the Port Authority will be responsible for annual operating and maintenance costs to be funded by terminal revenues.

 The great majority of the pavement for automobile staging will be light duty asphalt. The Port Authority is considering using permeable paving in these areas to reduce stormwater runoff. For new buildings, LEED standards will be evaluated also. The final decision will be based upon the recommendation of the facility design engineer.
- Because the Gulf Coast Restoration Trust Fund will receive deposits over a 15-year period, the Council may consider funding projects in phases. Estimated Useful Life

The Alabama State Port Authority computes depreciation by using the straight-line method and estimated useful lives of assets with no consideration of salvage value. The Benefit Cost Analysis (BCA) prepared by Moffattt and Nichol for this project provides a monetization and discounting of project costs over a 20-year horizon. The engineering designs for the Facility exceed the 20-year BCA horizon; therefore, it is expected to retain 33% of the construction value. Using the same assumptions as the BCA and applying the Alabama State Port Authority's straight-line depreciation method, with no consideration of salvage value, results in a useful life of 30 years as designed by the engineers, Moffatt and Nichol.

Indirect Cost Rate

Indirect costs are not included in our budget.

The Alabama State Port Authority is in the process of obtaining the information needed for the items listed below:

- 1) Legal documents relating to title (i.e. recorded easements, liens, rights-of-way, real property acquisition, conveyance), construction (i.e., permits, performance bonds), and disclosure or ongoing property litigation.
- 2) Recent title opinion showing ownership of the property and any deed restrictions. If the title opinion is more than one year old, a justification also must be provided for review and approval.
